## TERMS AND CONDITIONS FOR CHANNEL PARTNERS

- 1) Every walk-in client accompanied by a channel partner /Representative will be registered under the Channel partners code for a period of 60 days. No client registration shall be done through Mails/Messages or over the telephone. Only site visits will be registered.
- 2) This registration shall give the Channel Partner exclusive rights for his client for a limited period of 60 days for closing the deal.
- 3) Channel Partner has to fill in the Client Registration form with all the requisite details including Phone numbers for the purpose of registration under his code.
- 4) Brokerage and slabs shall be paid as per company policy from time to time.
- 5) No registration will be done for already registered clients i.e clients registered under the code of other channel partners / registered under DST until the expiry of registered duration.
- 6) In case of any dispute arising regarding any claim in booking due to multiple registrations under different family members name, management decision shall be binding in case to case basis.
- 7) No booking shall be accepted below the last login rates as decided and conveyed from time to time.
- 8) Company doesn't endorse any kind of credit notes and the channel partners shall not offer any kind of credit notes / discounts over and above the last login rates.
- 9) Channel partner shall not make any commitments other than what is explicitly mentioned in the sales brochure. Any commitment shall be done only after written approval from the Promoter-developer manager. Channel partner shall be held responsible if any claims arising out of any mis-commitments. Channel partner hereby confirm to indemnify Promoter/promoter-developer manager for any such claims.
- 10) Channel partner confirms to abide the guidelines issued by promoter/promoter-developer manager, concerned RERA authority and all government regulations
- 11) Channel partner undertakes to intimate the promoter/promoter-Developer manager immediately in case of deregistration with RERA authority and GST.
- 12) In case of any disputes regarding any claims/booking for his registered clients the matter shall be reported promptly to the management. Management decision shall be final and binding on all the concerned channel partners.
- 13) Company/Promoter/developer promoter reserves the right to modify /withdraw the registration policy at any point of time at its sole discretion.
